- As it becomes ever more crucial for institutions to demonstrate their value and impact, librarians are uniquely positioned to offer strategic support through bibliometric analysis. By applying basic bibliometric techniques, librarians can support strategic decision-making, contribute to institutional evaluations, and enhance visibility of local research output. At the same time, we are increasingly asked to do more with less in our libraries - both with staff time and budgets. This presentation explores options of accessible and freely available tools to generate meaningful insights into research trends, collaboration networks, and research impact.

In this workshop, the instructor will demonstrate how to reinforce the folds of bifolios such as endpapers (guarding) and how to re-attach pages back in place (tip-ins and hinge-ins). We will discuss the types of tools and materials needed and the instructor will share a list of conservation supplies and vendors. If time allows, a demonstration on how to tighten the hinges of worn books to prevent the sagging of the text block will also be performed.

This presentation offers an update on the Lloyd Best Archives Project, a post-custodial archival partnership centered on preserving and providing access to materials that remain in Trinidad and Tobago. It will highlight project progress, current workflows, and the role of collaboration in sustaining community-centered stewardship. The presentation will then explore how JSTOR Seeklight might support description, discovery, and access within this project. In doing so, it asks a set of urgent questions: Does AI-enhanced discovery compromise the premises of post-custodial archiving? Does it diminish intellectual control over archival materials? And under what conditions, if any, should AI be used in post-custodial archival practice?

Boston Public Library (BPL) has developed Snapicat, a tool which harnesses the WorldCat Metadata API to allow catalogers to iteratively batch-search bibliographic data stored in spreadsheets against standard WorldCat indexes to identify and retrieve the best matching OCLC records. Snapicat has extended our ability to catalog collections too big for typical book-in-hand workflows through upskilling our department and collaborating with non-cataloger data entry partners. Learn how BPL has incorporated Snapicat into multiple workflows relevant to academic and public libraries alike to achieve significant at-scale outcomes for our collections.
